POWER OF ATTORNEY

do hereby grant to LUIS ALBERTO SALOMONI (Reg.No. 2743), RAFAEL AUGUSTO SALOMONI (Reg.No. 3400), ALEJANDRO SCHMEDA (Reg.No. 4439), a full and sufficient Power of Attorney to act jointly, separately, or alternatively and to apply before the proper National Bureau and any administrative or judicial Authorities of the Republic of Paraguay for the issuance of trademarks, industrial models and designs, letter patents, Copyrights, utility models and all other intellectual property rights to which end they are empowered to take all necessary steps before said Authorities for the aforesaid purpose; to file applications and renewals; to prepare descriptions, make protests and declarations; to enter appeals and withdrawals; to pay taxes; to prove workings; to bespeak certified copies; to receive documents; to withdraw applications; to collect and receive sums of money; to accept assignments, and to do all and whatever shall be necessary before any administrative or judicial authorities; and to oppose, enter cancellation actions and protest against applications or registrations which, in the opinion of the Attorney, may cause confusion, or in any other way prejudice the marks, trade names, patents, industrial models, designs or copyrights of the Grantor. They are authorized to substitute this Power of Attorney either wholly or in part and to revoke substitutions. They are further authorized to appear at any Courts as plaintiff or defendant before the competent Judges, with power to compromise, submit arbitrations, relinquish, collect and file any appeal, and to enter judicial actions, to file replies or to counterclaim, to grant or demand securities, to give or demand bonds, bails, sureties, attend hearings; file letters requisitorial, to file exceptions and the like and to withdraw them, , with all such powers as may be required for the fulfillment of the present mandate.
